**How We Will Calculate Your Balance:** We use a method called “average daily balance (including current transactions).” See your account agreement under Finance Charge for more details.

**Member Choice Rewards Terms & Conditions:** Earn 1 point per dollar spent on purchases; returns will be deducted from the bonus point calculation. There is no limit to the amount of points you can earn. If your account is closed, voluntarily or involuntarily, or past due, you will forfeit all points. Accounts without purchase or cash advance activity for twelve (12) months will forfeit all points. Your points will expire after five (5) years, with the oldest points expiring monthly.

**How We Will Calculate Your Variable Rate:** Your variable rates may change when the Prime Rate changes. It is determined by adding 7% to the highest U.S. prime rate published in *The Wall Street Journal* “Money Rates” table on the 15th business day of the month quarterly in January, April, July, & October. The rate is effective on the first day of the billing cycle.

**Billing Rights:** Information on your rights to dispute transactions and how to exercise those rights is provided in your account agreement.
